

## The Truth About Dogs Terms and Condition Agreement

1. **\*\*If my pet(s) arrives and has diarrhea at any point during their stay, I hereby authorize The Truth About Dogs, School For Dogs to take a stool sample to a licensed Veterinary Clinic to test for intestinal parasites alongside request a 'Giardia Snap Test'. I understand that this is for the protection of my pet(s) as well as the other pets that board or live at The Truth About Dogs, School For Dogs. All costs incurred shall be my responsibility and shall be paid in full upon the pickup of my pet(s)\*\*** Initial \_\_\_\_\_
2. In the event of an emergency involving the health of my pet(s), I hereby authorize The Truth About Dogs, School for Dogs and its staff to seek veterinary attention, if advised to hospitalize my pet(s), and to administer medications, tests, or treatments that the veterinarian(s) may deem necessary for the health, safety and well-being of my pet(s) while at boarding/daycare. All expenses so incurred shall be my responsibility and shall be paid in full upon pick up of my pet(s).

3. If we cannot contact you OR your emergency contact directly, you agree and allow us to do whatever is necessary in an emergency situation. Initial \_\_\_\_\_
4. If you have a particular amount of money that you do not want us to exceed with necessary medical care, please inform us now **(if left blank, that means no limit).** \$ \_\_\_\_\_
5. Except in the event of gross negligence, I agree to waive and release The Truth About Dogs, School for Dogs and/or its employees from any and all liability of any nature including any injury, death, sickness, property damage or loss that my pet(s) may suffer during or after daycare or being boarded. I also agree to indemnify and hold harmless TTAD for any and all claims due to any damages my pet(s) may cause to any third parties during or after play-care or boarding. Initial \_\_\_\_\_
6. I acknowledge that my pet(s) are healthy and current on all vaccinations: Rabies, Distemper, Hepatitis (Adenovirus), Parainfluenza, Bordetella, Leptospirosis. Please bring proof of vaccine. Initial \_\_\_\_\_
7. It is recommended that all dogs are spayed or neutered if over 12 months of age when participating in group play. I understand that if my dog is intact that they may not be able to engage in group play due to heat cycle if female or overly obnoxious courtship behaviors if male. Initial \_\_\_\_\_
8. For the health and wellness of other pets, we may not accept pets with open wounds or sores. No pets with ticks or fleas will be accepted. No pets with recent (within 14 days) illness (i.e. vomiting, diarrhea, coughing, or sneezing) will be accepted for group play. By presenting my pet for participation in The Truth About Dogs daycare/boarding program, I am verifying that my pet is free of infectious disease and has shown no clinical signs of illness for 14 days prior to admittance into group play. Sick pets may board on a medical boarding basis if previously approved. Initial \_\_\_\_\_
9. Quick Release collars with name tags and phone numbers are highly recommended. A loner collar will be provided until you can provide one. Initial \_\_\_\_\_
10. The Truth About Dogs will not be responsible for any personal supplies, toys, blankets, etc left with any pet(s). Initial \_\_\_\_\_
11. All dogs participating in group play must undergo a supervised behavioral assessment (depending on the situation this may need to be scheduled as a meet and greet- the charge is \$10 and The Truth About Dogs can require this of any dog whose owner is seeking service here). If your dog is deemed unsuitable for group play, our staff will be in contact with you, and your pet will be assigned to limited or private play groups. Initial \_\_\_\_\_
12. I understand that during group play with other dogs, injury, illness, or death may occur. I willingly accept the risk of and responsibility for the cost of treatment for any such injury or illness. I further release, indemnify and hold harmless The Truth About Dogs, it's owners and employees from any and all claims arising from my pet's conduct or any damages, illness or injuries caused or sustained by my pet(s) or myself as a result of participating in play. 13. If I do not pick up my pet(s) within 12 days after receiving written notice from The Truth About Dogs stating our intention either to re-home, shelter, or euthanize the animal(s), TTAD may assume that my pet(s) are abandoned. Abandonment does not release me from the obligations for the bill. **Initial** \_\_\_\_\_
14. I hereby authorize The Truth About Dogs, to post and display pictures and or videos of my pet(s) on their website, social media sites or promotion materials. This photograph/video will not be used without my express written/electronic permission. **Initial** \_\_\_\_\_
15. Boarding charges accrue starting the day of drop off regardless of the time your pet(s) arrive(s). If you pick your pet(s) up by 9:00 am on the departure date, you will not be charged for that day. If you pick your pet up after the designated pick up and drop off times, you will be charged a convenience fee of \$15/pet rather than another overnight charge. **Initial** \_\_\_\_\_
16. We would like to remind you that you are responsible for any charges incurred during your pet's stay with us. Payment is due at time of service in the form of check or cash. If your pet's stay will exceed three weeks, we will need a 50% deposit prior to his/her/their stay. If their stay will be extended beyond the prior agreed departure (extending past these three weeks), we will need a full payment of their current boarding and any medical charges upon this extension . **Initial** \_\_\_\_\_
17. I agree to pay reasonable attorney fees incurred by The Truth About Dogs in the collection of any and all fees resulting from the care and maintenance of my pet(s). I further agree that in the case of non-payment, a finance charge of 1.5% per month (18% annually) will be charged. **Initial** \_\_\_\_\_
18. I have read and fully understand and agree to the terms above. I understand and agree that all fees are due and payable when I pick up my pet(s). This policy and agreement shall apply indefinitely and during the course of each and every visit I or my pet(s) makes to The Truth About Dogs. **Initial** \_\_\_\_\_
